Change of Financial Circumstances

Required documentation:

- A detailed personal statement of circumstances for loss of employment; include current work status and pay frequency.
- A signed copy of your (or your parents', if dependent) 2020 tax return. Must be signed by filer.
- Documentation from former employer confirming loss of income, date of separation, and amount of severance pay (if any).
- Copies of most recent full month's pay stubs from current job (if applicable).
- A copy of the Texas (or applicable state) Workforce Commission Claim and Payment statement (unemployment benefits, etc.)
- Completion of the verification process. Upon submission of this form, the Office of Financial Assistance will notify you of the required documents to complete the verification process.

Change in household size* due to pregnancy:

Required documentation:

- Attach a letter from your obstetrician indicating the date and proof of pregnancy.
- Completion of the verification process. Upon submission of this form, the Office of Financial Assistance will notify you of the required documents to complete the verification process.

Unusual Medical Expenses

Required documentation:

- Attach a copy of your 2020 Schedule A Form from the 2020 Federal tax return. Expenses are considered unusual if they exceed 11% of the family's income. Expenses must appear in the 2020 Schedule A form.
- Attach a detailed letter explaining what the medical expenses are for. Orthodontic expenses will not be considered.
- If the Schedule A is not available, please submit Explanation of Benefit forms for the claimed expenses. Expenses for medical premiums and amounts covered by insurance will not be considered.
