Eligibility and Guidelines

- Exhibits entrepreneurial aspirations and a propensity for leadership and innovation
- Exhibits proven entrepreneurial track record (preferred)
- Is studying at an institution of higher learning in Texas and is enrolled in or associated with a business or entrepreneurship program in Spring and Fall 2021
- Exhibits leadership in campus and community activities
- Plans to pursue a career in Texas
- Good academic credentials
- Graduate or Masters in Business/MBA students preferred, exceptions made for high quality undergraduate students
- Able to attend the TBHF Annual Scholar Award Luncheon and Induction Dinner (both occur on October 28, in Dallas; attendance is required to receive award)
- Able to travel for interviews (when applicable) and events (at the candidate's expense)

Financial need may be considered, but is not a requirement for application.

For students enrolled in a non-standard or accelerated academic program, exceptions will be made, as arranged with the Dean and approved by TBHF, prior to the submission of your application.
