#### V. COURSE REQUIREMENTS AND GRADING

## Projects and Assignments:

#### <u>Quizzes</u>:

Quizzes will be given using Blackboard. Quizzes will be over the material previously covered in class and the readings. Quizzes will be posted one week before they are due. Quizzes are due at the beginning of class on the date due. I strongly suggest you set up alerts in blackboard to know when quizzes are posted.

#### Participation:

Students are expected to actively participate in group discussions and ask questions of guest speakers. Part of this involves a minimum of one weekly reaction posting to the question or thought posted by the instructor online.

**Daily Writing:** Each day when you come to class, you must bring 2 copies of a one page summary that reflects the topics to be discussed in lecture that day. Your name must be on the papers, it must be typed, and it will be used as attendance for class. You will turn in one copy to me as you come into class and you will edit the copy that you have with you during lecture. It is a great way to have notes for your exams. To receive full credit for daily writings, you must complete 8 of the 10 assigned writings. To receive half credit 5 – 7 of the assigned writings must be completed. No credit will be given for less than 5 completed assignments.

#### Tattoo/piercing Paper

The purpose of the paper is to explore the varied reasons why these forms of body modification have become so widespread. You will interview 3 people who have tattoos and/or piercings asking questions about the motivations, the experience itself and current feelings about the results. Draw comparisons to the reasons for similar modifications from the lectures. The paper will be 5-6 pages long. More information will be on the research paper tab in Blackboard.

#### Ethnic/cultural identity paper

This will be combination of observation, interview and research. You will select a cultural event. After attending the event and talking with at least 3 participants about his/her dress, you will write an 7-8 page paper describing

the event overall, describing the special dress in detail, and then present your analysis as to how the dress functions as a means of either group or individual identity or both. The analysis will be based upon material that you have learned in class and will be referenced and cited. More information will be on the Research paper tab in Blackboard.

#### Research Project:

Each student will select a topic related to dress and culture. The topic must be approved by the instructor. The student will then thoroughly research that topic, and write a research paper including visuals and a bibliography.

You will present your research to the class on the day of the last day . Further specifications will be given on Blackboard and in class.

#### Final Exam:

The final will be cumulative. A review will be posted in Studymate at least one week before the exam.

**B. Student Evaluation:** Students will be evaluated on their ability to meet the course objectives based on their fulfillment of the class projects and assignments.

Late Assignments: LATE ASSIGNMENTS WILL NOT BE ACCEPTED. All assignments are due at the beginning of class unless otherwise noted in the syllabus. All assignments unless otherwise instructed must be turned in through blackboard by the time class starts. Only students with an excused absence (doctor's note required) will not be faulted for a late assignment. **Performance Level:** To obtain an "A" in this course, the student must maintain accuracy in all of their projects. In addition, every project is to be on time, with no more than 2 absences. Only the highest-level students will receive an "A". Simply being present and turning in assignments does not "entitle" one to an "A". Nor does it "entitle" one to any other passing grade. Only absolute excellence in work and a terrific attitude as well as other factors earns one an "A". Even just to receive a passing grade will require a lot of hard work and diligence to meet the

requirements of the course and the assignments. A passing grade does not mean that the project was merely completed, but that it was also deemed acceptable by the instructor and met ALL of the guidelines.

#### VI. Participation, Punctuality and Attendance:

#### Attendance Policy for Lecture Classes:

Attendance and participant in this class is mandatory. In addition to maintaining the appropriate average in any class, ATTENDANCE WILL AFFECT THE FINAL GRADE IN THE FOLLOWING WAYS:

As this class meets only twice a week, students are allowed 2 absences from this course during the semester. This includes on-line discussions and lectures. **Each** additional absence will result in the loss of 5% from your final course average. (Department Policy).

#### Absences:

On days there is not a daily writing assignment due, there will be a sign in sheet at the front of the classroom each day. On days there is a daily writing assignment, these will be used for attendance. *It is YOUR responsibility to sign in for class or turn in your daily writing assignment – not the instructor's.* Students that are in class, but did not sign in or turn in their writing assignment are still considered absent. A copy of the sign in sheet or daily writing check sheet will be posted in Blackboard under the Check your attendance tab. The sheets will be posted once a week. Review this before you email me to find out when you were absent.

ALL absences count regardless of being excused or unexcused. However, an excused absence will allow you to make up missed work, whereas an unexcused absence does not. An excused absence is defined as a verified illness, family emergency, religious observance, or University-sponsored event. A doctor's note is required for an illness to be excused. Notice of funeral or some other form of official documentation is needed for family emergencies. ALL UNDOCUMENTED ABSENCES are unexcused.

# Documentation:

All excused absences must be accompanied by proper documentation within ONE WEEK of the student's return from his or her absence. If documentation is not provided within one week, the absence will count as unexcused, which means work missed that day cannot be made up.

#### **Officially Approved Trips:**

The University of the Incarnate Word Catalog states that the person responsible for a student missing class due to a trip should notify the instructors of the departure and return schedule in advance of the trip. The student may not be penalized and is responsible for the material missed. Remember: This still counts as an absence. It just means you are allowed to make up your work within the pre-arranged amount of time.

#### **Religious Observances:**

A student who is absent for the observance of a religious holy day will be allowed to complete the assignment scheduled for that day within one week of the absence. Prior notification to the instructor is requested. Remember: This still counts as an absence, however, students are allowed to make up work within the pre-arranged amount of time.
